Currently, 49.8% of the 79,547 housing units in the area are owner occupied; 39.8%, renter occupied; and 10.4% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 68,160 housing units in the area - 52.2% owner occupied, 38.0% renter occupied, and 9.8% vacant. The annual rate of change in housing units since 2010 is 7.11%. Median home value in the area is \$149,494, compared to a median home value of \$207,344 for the U.S. In five years, median value is projected to change by 2.16% annually to \$166,316.
