Currently, 50.1% of the 211,523 housing units in the area are owner occupied; 36.4%, renter occupied; and 13.6% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 205,803 housing units in the area - 54.3% owner occupied, 33.0% renter occupied, and 12.7% vacant. The annual rate of change in housing units since 2010 is 1.23%. Median home value in the area is \$155,403, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 3.69% annually to \$186,305.
